EXECUTIVE SUMMARY

Merv is a tokenized investment platform that brings real-world assets on-chain, starting with high-demand luxury and commercial vehicles rented in Dubai. Through the \$MERV token, users gain co-ownership, yield access, and priority exposure to new real-world asset offerings. We are solving the problem of asset illiquidity, exclusivity, and inefficiency by leveraging blockchain to make cash-flowing assets accessible globally.

PROBLEM STATEMENT

Traditional assets are outdated. Investing in real estate or vehicles that generate rental income is costly, exclusive, and administratively slow. Meanwhile, anyone can buy a meme coin in seconds. This disconnect represents a massive inefficiency in capital markets and access.

Real-world assets (RWAs) suffer from:

- Illiquidity and lack of transparency.
- High entry barriers and restricted access.
- Centralized inefficiencies in asset management and revenue distribution.

Merv fixes this.

We bridge real-world yield with Web3 accessibility and transparency.

THE MERV SOLUTION

Merv tokenizes real-world vehicles in Dubai and distributes the revenue generated by their rentals to token holders. All Merv vehicles are revenue-generating assets operating in partnership with licensed local rental operators.

Key Utilities of \$MERV:

- **Revenue Participation:** Pro-rata share of net income from vehicle rentals.
- Access & Privileges: Exclusive investor events, early access to future STOs, and private deals.
- **Future Perks:** VIP access to the car fleet, luxury events, and product co-creation.
